Introduction

This report has adopted the definitions provided by CHEDS for data categorization.

A “transferred student” is one who has transferred from another institution and is undertaking his/her first semester of study at MBRSG. For the purpose of this report, a “transferred student” has been categorized as a “new student”. A “continuing student” is a student who has completed at least one module of study at the institution. For the purpose of this report, a “readmitted student” has been categorized as a continuing student. A “readmitted student” is a student who has finished at least one module of study with the School and resumed studies after a period of leave of absence/suspension/deferral.
